The South Carolina Child Care Licensing Law, Section 20-7-2725 D. et seq., Code of Laws states, "To be employed by or to provide caregiver services at a day care facility licensed, registered, or approved under this sub-article, a person must first undergo a state fingerprint review to be conducted by the State Law Enforcement Division to determine any state criminal history and fingerprint review to be conducted by the Federal Bureau of Investigation to determine any other criminal history."

A person who has been convicted of a crime enumerated in subsection (A) who applies for employment with, is employed by, or seeks to provide caregiver services or is a caregiver at this facility is guilty of a misdemeanor and, upon conviction, must be fined not more than five thousand dollars or imprisoned not more than one year, or both.
